

**GLOBAL LINK CYBER INTERNATIONAL LTD :
WHERE'S MY \$HK8.50 MILLION ?**

Global Link Cyber International Ltd (Code: 140, Main Board, The Stock Exchange of Hongkong Ltd) has been sued for about \$HK8.50 million by a property consultant, which alleges that it never got paid that money which is due to it.

According to High Court Action Number 2116 of 2001, China Energy Promotion Ltd was commissioned by Global Link (formerly known as Kong Tai International Holdings Company Ltd) to negotiate and to assist in the negotiations and execution of an exchange of properties between Global Link and Guang Xin Enterprises Ltd (in Creditor's Voluntary Liquidation).

According to the Statement of Claim, attached to the Writ of Summons, Guang Xin Enterprises owned Numbers 2-4, Russell Street, Causeway Bay, and Numbers 6, 7, 8 and 9, Canal Road East, Causeway Bay, Hongkong.

Global Link, on the other hand, owned the following pieces of property:
