After so many years, one would have thought that one could get used to noting that leading barristers in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) get in and out of trouble with creditors and, even, with the management of companies, from which they enter into leases to rent offices/chambers.

Mr Ronald Edward Mayne was called to The Bar in the United Kingdom in 1972 so that one may safely say that he is at least 50-odd years old.

He works out of his Chambers, located on the 12<sup>th</sup> Floor, Fung House, Number 19-20, Connaught Road, Central.

This is the same address that Hang Wah Chong Investment Company Ltd sent its challenge to Mr Ronald Edward Mayne, recently, informing the Queen's Counsel of the pending proceedings against him.

Hang Wah Chong is a wholly owned subsidiary of CITIC Pacific Ltd (Code: 267, Main Board, The Stock Exchange of Hongkong Ltd).

This is not the first time that Mr Ronald Edward Mayne has been on the receiving end of Bankruptcy Notices since **TOLFIN**'s records indicate that he has been the lucky recipient of at least 2 other Notices of Bankruptcy. (**TOLFIN** is **TARGET**'s Computerised Online Financial Service).
