

**MEDICAL CHINA LTD :  
COOKING UP CURES FOR CANCER**

Medical China Ltd has discovered a cure for pancreatic cancer.

This is stated at Page 64 of the Company's Placing Prospectus, distributed on December 19, 2001.

The excerpt from Page 64 is:

*'In March 2000, after entering into a cooperative contract with Wuzhou Tat Lung (Guangxi Wuzhou Tat Lung Medical Equipment Company Ltd [a transliteration of the Chinese entity's name, only]), Baiqiuen International Peace Hospital used RFAS (The RFAS system of Medical China consists of a Radio Therapeutics Radiofrequency Generator, LeVein Electrodes, an ultrasonic scanner, a personal computer, and the software to run the system) for treatment of pancreas cancer, which the Directors believe, was the first application of RFAS for treatment of pancreas cancer in the PRC (People's Republic of China). The operation was successful.'*

There you have it!

The medical breakthrough, it appears, however, has yet to filter down to the Hongkong Medical Association, the British Medical Society, or even the lowly American Medical Association.

Ah, well! With the publication of the Placing Prospectus of Medical China Ltd, the world will come to learn of the benefits of RFAS; and, this knowledge will push up the profits of this small Company into the financial stratosphere.

This discovery may be greater than the invention of the aspirin. Who knows?

Medical China was the last Company to go public on The Growth Enterprise Market (The GEM) of The Stock Exchange of Hongkong Ltd, just before the Christmas break.

It Placed 144 million, one-cent shares at a Premium of 49 cents per share, raising about \$HK60 million, net of expenses.

The money, collected via the Share Placements, is to be used, the Prospectus states, as to:

1. \$HK21 million for the establishment of 30 RFAS treatment centres in the PRC;
2. \$HK4.50 million for the promotion of the application of RFAS, and the establishment of 4 RFAS training centres for staff of the hospitals in the PRC;
3. \$HK9 million for the development of the market for, and investment in, 3-dimensional laparoscope (a slender, tubular endoscope that is inserted through an incision in the abdominal wall to examine or perform minor surgery within the abdominal or pelvic cavities) as well as assisting in the sale of anti-cancer drugs;
4. \$HK24.90 million for the establishment of 2 cancer treatment centres in the PRC; and,
5. \$HK600,000 for General Working Capital purposes.

## **The History**

Medical China was founded on April 25, 2000, but it can trace back its origins to Dr James Li Nga Kuk, who is described in the Placing Prospectus, at Page 62, as being '*a medical doctor and has extensive knowledge of the medical device and pharmaceutical industries ... more than 10 years of experience in introducing advanced medical devices for treatment of tumors from the United States to the PRC ... introduced a medical device for treatment of Pakinson's Disease ...*'. (TARGET has no idea what is Pakinson's Disease and wonders whether or not it is a '*brother*' or '*cousin*' of Parkinson's Disease)

In February 1999, Page 63 states, Dr James Li met Mr Ng Kwai Sang, the present Deputy Chairman of Medical China, and thus was formed a bond whereby Mr Ng would employ his utmost endeavours to flog the discoveries of the great doctor, while the doctor would continue to make new and even greater discoveries in the field of medical devices and what-have-you.
