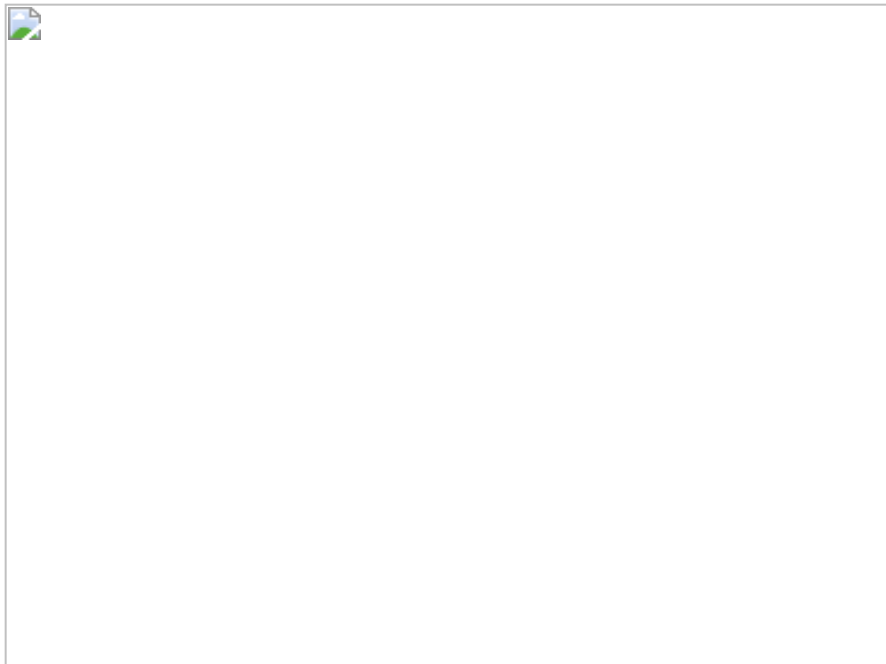


**BODY BY DEBORAH INTERNATIONAL HEALTH AND BEAUTY SPA :  
ANOTHER LIE OF DEBORAH ANN SIMS**

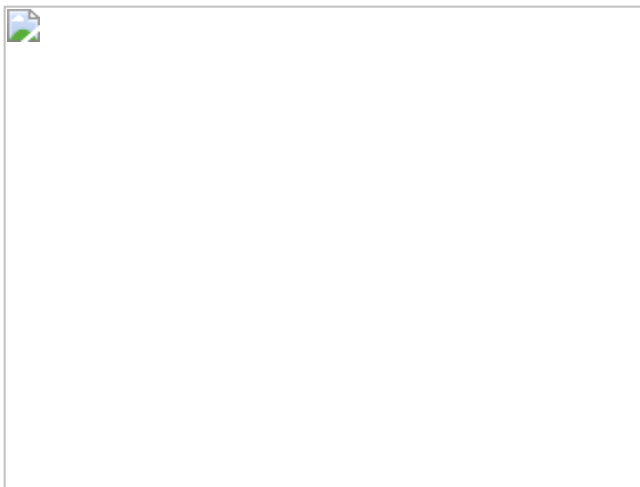
Body by Deborah International Health and Beauty Spa will not be re-opening for business – because, effectively, it no longer exists.



**Locked and  
Bolted !**

The offices have been seized by Court Order, instituted by the landlord, Deluxe Plan Enterprises Ltd, a subsidiary of Sun Hung Kai Properties Ltd (Code: 16, Main Board, The Stock Exchange of Hongkong Ltd).

The High Court Ordered the seizure of the offices, presently occupied by Body by Deborah International Health and Beauty Spa, on Saturday, March 9; and, it was served on the spa-cum-massage parlour's front office, located on the 6<sup>th</sup> floor of World Trade Centre, Causeway Bay, last Thursday, March 14.



### **The Court Order**

A chain has been affixed to the doors of the main entrance of Body by Deborah International Health and Beauty Spa, barring entry to everybody.

So ends the lies of Ms Deborah Anne Sims, the Founder of Body by Deborah International Health and Beauty Spa, at least in respect of this facility, re-opening for business.

In TARGET's last report about Body by Deborah International Health and Beauty Spa, published on February 18, 2002 (Please see [TARGET Intelligence Report, Volume IV, Number 31](#)), this medium, having visited the premises at World Trade Centre and having read an official notice, placed there by Management on the main door, reported that the spa-cum-massage parlour was to be re-opened in the middle of March.

That announcement said that Body by Deborah International Health and Beauty Spa would be re-opened on March 15 – last Friday – and that it would commence business, the following day.

Well, that is just not going to happen, friends and neighbours.

Stand by for an avalanche of writs from what must surely be an army of disgruntled tai-tais and O.L.s (tai-tais = Married Chinese ladies of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC); O.L.s = Professional Office Ladies of the HKSAR), many of whom paid tens of thousands of dollars for the privilege of making use of the once, luxury spa and beauty salon of Ms Deborah Anne Sims, would-be socialite of the territory.

According to the Court Order, Body by Deborah International Health and Beauty Spa has until this Friday to take out all of the goods and chattels, stored on the 5<sup>th</sup> floor and 6<sup>th</sup> floors of World Trade Centre, failing which the landlord will enter the premises and dispose of the stuff, reposessing the property in accordance with the determination of the Court.
