While the number of Writs, filed in various Courts of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) against companies, within the Great Wall Cybertech Ltd group of companies, only numbers 23 since the beginning of this year, and while the amount of money, claimed in these Writs is not, really, material, relative to the 2002 Turnover of Great Wall (\$HK1.91 billion), there are, without question, important moves afoot within the company, to be sure.

And these moves either will save the company or will exacerbate a very ticklish financial situation.

According to **TOLFIN** (**TARGET**'s Computerised Online Financial Service and Credit-Checking Provider), not less than 20 subsidiaries and 2 associated companies have been deleted from the Annual Report of Great Wall Cybertech for the Financial Year, ended March 31, 2002.
