PICO FAR EAST HOLDINGS LTD: IS THE BUSINESS CENTRE HAVING A WEE BIT OF TROUBLE, THEN?

The Wanchai business centre, owned as to 50 percent by publicly listed Pico Far East Holdings Ltd (Code: 685, Main Board, The Stock Exchange of Hongkong Ltd), appears to be in serious trouble.

While Management of Pico Far East has yet to make any kind of an announcement about this Wanchai business centre, **TOLFIN**'s* records suggest, strongly, that the business centre could close its doors, any day now.

After all, how many companies can be said to be in enjoying financial health when landlords are on the attack, knocking at their doors, monthly, for more than one year?

The business centre is located at Central Plaza, 35th Floor, Harbour Road, Wanchai, the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC).

It is operated by Allied Pacific Investment Ltd, which, in turn, is owned as to 50 percent by Pico Far East.

According to **TOLFIN**, since January last year, Allied Pacific has attracted not fewer than 14, HKSAR District Court Claims and one case, lodged in the Small Claims Tribunal.

The aggregate amount of these 15 claims is at least \$HK4.25 million.

The claims, according to **TOLFIN**, are:
