

**MOISELLE INTERNATIONAL HOLDINGS LTD :  
SARS CUTS A SWARTH THROUGH THE COMPANY'S PROFITS**

Claims continue to pile up against publicly listed Moiselle International Holdings Ltd (Code: 130, Main Board, The Stock Exchange of Hongkong Ltd) with a further \$HK2.11 million, being claimed in the District Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) by corporate landlords of the garment-maker and designer of fashion clothes for the younger set.

The latest claims include the \$HK1.26 million, which this medium reported in [TARGET Intelligence Report, Volume V, Number 110](#), of June 13, 2003.

The latest claims, compiled by **TOLFIN** (**TARGET's** Computerised Online Financial Intelligence Service and Credit-Checking Provider), indicate that some 12 companies have issued legal proceedings against various companies, within the Moiselle Group, each claimant, seeking relatively small sums of money, ranging from \$HK55,728, the smallest sum of money, to \$HK331,470, being the greatest amount of money.

This is the latest state of play, as far as legal claims against this fashion company are concerned:
