## TERABIT ACCESS TECHNOLOGY INTERNATIONAL LTD: DOWN AND DOWN SHE GOES, AND WHERE SHE STOPS, NOBODY KNOWS

Terabit Access Technology International Ltd (formerly known as Welback Holdings Ltd) appears to be continuing to have extreme financial problems.

With claims, piling up against its subsidiaries, one has to wonder, exactly, what is going on in this publicly listed company, which is listed on The Stock Exchange of Hongkong Ltd, being Stock Code 491, Main Board.

Recently, 3 suppliers of Welback Enterprises Ltd, a 51-percent-owned subsidiary of Terabit Access Technology, sued the company in the District Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) for about \$HK700,000, in aggregate.

Welback Enterprises describes itself as being in the business of manufacturing and sales of toys and games and multimedia electronic products.

Prior to the July District Court Writs, various companies within the Terabit Access Technology Group were sued in various other HKSAR Courts.
