

**SURGE RECREATION HOLDINGS LTD:
CHAIRMAN LI TAT TING ‘HIT’ ONCE MORE**

The Chairman of [Surge Recreation Holdings Ltd](#) (Code: 703, Main Board, The Stock Exchange of Hongkong Ltd) has been sued in the District Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) for the seemingly modest sum of \$HK161,376.

A party by the name of Cheung Lin Fong sued Mr Li Tat Ting, last week, alleging that Mr Li Tat Ting issued 2 cheques to Cheung Lin Fong, but both cheques were dishonoured on presentation.

The alleged misdeeds of Mr Li Tat Ting go back to August and September 2000, the District Court Statement of Claim, attached to the Writ of Summons alleges.

This is not the first time that this gentleman has been nobbled by a party, claiming to be owed money by this businessman because the records of **TOLFIN** (**TARGET**'s Computerised Online Financial Intelligence Service and Credit-Checking Provider) indicate that he has been sued not less than 8 times in the past 30 months.
