RUILI HOLDINGS LTD: THE CORPORATE 'CAT' WITH MANY LIVES

Despite having 33 creditors, chasing this company for money, aggregating about \$HK8 million, all of which is, allegedly, owed to these creditors since the beginning of this year, it appears that Ruili Holdings Ltd, the new name of <u>Terabit Access Technology International Ltd</u>, is going to get a new lease on its corporate life, after all.

On September 29, 2003, it was announced that a Mr Lu Chieh Kang, via his holding company, had lent money and invested in Ruili Holdings to the tune of a little more than \$HK21 million, \$HK16,037,700 as an investment, for which he received about 700 million New Shares in the Issued and Fully Paid-Up Share Capital of the company, and a \$HK5-million, one-year loan, which bears an interest factor of 8 percent per annum.

That Ruili Holdings was desperate for cash is obvious because this company has not earned a crumb since May 1998.

This is, at least, the second time in the past 4 months that Management of Ruili Holdings has managed to suck in new cash of a material nature into its coffers.

In June, this year, when Ruili Holdings was known as Terabit Access, it engineered a New Share Placement, at which time, it managed to bring in about \$HK15.50 million.

This toy company, which is listed on the Main Board of The Stock Exchange of Hongkong Ltd, being Stock Code Number 491, appears to have a knack for attracting investors – as well as attracting litigation ... one claim after another.

According to **TOLFIN** (**TARGET**'s Computerised Online Financial Intelligence Service and Credit-Checking Provider), the aggregate losses of this company, during the past 4 Financial Years, ended June 30, 2002, were about \$HK188.36 million.

During that period of time, Shareholders' Funds fell from about \$HK108.88 million (in 1998) to about \$HK41.46 million, as at the 2002 Balance Sheet Date.

For the first half of the 2003 Financial Year, to December 31, 2002, the company racked up an Interim Loss of about \$HK30.77 million, bringing up the total losses for the past 54 months to about \$HK219.13 million.

In addition, since January 2003, the following claims have been lodged against the company and/or its subsidiaries in various Courts of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), according to **TOLFIN**'s records:
