Universe Dragon, according to the 2003 Annual Report of G-Prop (Holdings), is in the business of 'Manufacturing and Leasing of Energy Saving Machines.'

The records of **TOLFIN** (**TARGET**'s Computerised Online Financial Intelligence Service and Credit-Checking Provider) state that, last Monday, 6 individuals filed High Court Winding-Up Petition, Number 1274.

The Petitioners are:

Cheng Pak Kow Li Wing Kin Tao Ka Yeun Nelson Leung Yau Fai Poon Sin Ha Wong Hon Sum

Mr Li Wing Kin was an Executive Director of G-Prop (Holdings) until April 8, 2003, when he threw in the towel and walked away from the company.

Universe Dragon has been known to **TARGET** for some time, now, due to numerous complaints that have been made against this company since December 30, 2002.
