## HON PO GROUP (LOBSTER KING) LTD: PITY THE MINORITY SHAREHOLDERS OF THIS COMPANY!

Publicly listed <u>Hon Po Group (Lobster King) Ltd</u> (Code: 228, Main Board, The Stock Exchange of Hongkong Ltd) continues to enjoy more financial headaches, as Heineken Hongkong Ltd, the supplier of Heineken beer in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), joins in the fun.

Because Heineken Hongkong Ltd has just hit 2, wholly owned subsidiaries of Hon Po Group with 2 claims, the aggregate amount of money, being sought in these claims, coming to about \$HK248,506.

The 2 subsidiaries are:

- Chai Wan Hon Po Restaurant Ltd
- Hon Po Rich Harvest Resources Ltd, trading as North Point Hon Po Restaurant

The 2 District Court Writs, levelled against the above-mentioned subsidiaries, are almost identical except for certain dates and the amount of money, allegedly owed by the subsidiaries to Heineken Hongkong Ltd.

The gist of the 2 claims is that Heineken Hongkong Ltd agreed to supply Heineken beer to Hon Po Group's 2 restaurants, located in North Point and Chaiwan, between July 2003 and January 2004.

But payment for the beer was never forthcoming, it is alleged in both claims.

The Chaiwan restaurant allegedly owes Heineken Hongkong Ltd about \$HK151,202 while the North Point restaurant allegedly owes Heineken Hongkong Ltd about \$HK97,304.

These are only the 2 latest claims against subsidiaries of this restaurant-owning company, which went public on The Stock Exchange of Hongkong Ltd in February 2002.
