RUILI HOLDINGS LTD: WINDING-UP PETITION FILED ON SUBSIDIARY

Star World Electronics Company Ltd has petitioned the winding up of Hitchman Ltd, a wholly owned subsidiary of <u>Ruili Holdings Ltd</u> (Code: 491, Main Board, The Stock Exchange of Hongkong Ltd).

Star World Electronics, which is in Creditors' Voluntary Liquidation, sued Hitchman on July 9, 2003, for about \$HK1.42 million, being, allegedly, Money Due and Owing.

Hitchman is a trader in toys, games and multimedia electronic products.

This subsidiary is no stranger to litigation since, according to **TOLFIN** (The Computerised Online Financial Intelligence Service and Web-Based, Credit-Checking Provider), it has been sued 11 times within the 7-month period, ended February 28, 2004, with the aggregate amount of money, allegedly owed to creditors, being not less than \$HK1.37 million.
