DEBORAH ANNE SIMS: NOW, HER COMPANY CANNOT EVEN AFFORD RENT OF \$HK3,700 PER MONTH

Logic dictates that one of the principal operating companies of Ms Deborah Anne Sims, once the toast of the physically fit, somewhat comely married ladies of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), that is before age and her former Australian husband kissed her goodbye, forever, must be reaching the end of the financial road.

Because <u>Tiger Eye International Ltd</u>, a company, beneficially owned by Ms Deborah Anne Sims, has been sued, once again, for not paying rent on its factory unit in Chaiwan, Hongkong Island.

This is the eleventh time of the past 10 months that this corporate entity of Ms Deborah Anne Sims has been called to task for not paying its debts of varying amounts.

According to Gee Chang Property Management Ltd, the corporate landlord of Factory F-2, on the Fifth Floor of Gee Tung Chang Industrial Building, Number 4, Fung Yip Street, Chaiwan, Tiger Eye International has not paid its rent since February, this year.

Gee Chang Property Management has launched an Action in the District Court of the HSKAR, seeking to recover the princely sum of \$HK14,800 from Tiger Eye International.

Simple mathematics suggests that Tiger Eye has not even the wherewithal to pay rent on this Chaiwan factory unit of just \$HK3,700 per month.

When a company cannot pay this piddling amount of money, then, it would be fair to say that it is, really, short of bread.
