

**TOPPAN PRINTING COMPANY (HONGKONG) LTD:
WINDING-UP PETITION FILED AGAINST
AN ENTITY OF ALBERT CHENG JING HAN**

When Toppan Printing Company (Hongkong) Ltd filed for the winding up of Chinese United Press Ltd, no doubt, Toppan Printing Company realised that its actions were quite likely to stir up a hornets' nest in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) – due to the personalities, beneficially, controlling Chinese United Press.

The man behind Chinese United Press Ltd is (or, at least, was) Mr Albert Cheng Jing Han.

Mr Albert Cheng Jing Han is, probably, best known in the HKSAR for the somewhat controversial, long-running, radio talk show, which he used to host, known as *'Teacup in a Storm'*.

After being beaten up by thugs, outside the radio studio, and following his *'failing memory'* of the crooks, who perpetrated the deed upon his body, he faded from view, to a great extent.

He threw in the radio hosting *'towel'*, according to his own admission, because of more threats to his life.

More recently, one is told that Mr Albert Cheng Jing Han might like to try to take his place in the history of the territory as a new Legislative Councillor.

Reports have it that he may be standing in the September Legislative Council Elections.

However, he has denied one such report, pertaining to his alleged political ambitions, claiming that he would be returning to the air, later in the year.

Evidently, there are no more threats on his life or, alternatively, he has been drinking an elixir to boost his courage?

But, before making a determination to seek election to the Legislative Council of the HKSAR, or returning to the air in order to steer his teacup in a storm, Mr Albert Cheng Jing Han will have to put the past well behind him, especially in respect of the latest matter: Winding-Up Petition Number 800 of 2004.

According to **TOLFIN** (The Computerised Online Financial Intelligence Service and Web-Based, Credit-Checking Provider), Chinese United Press Ltd would appear to be in violation of The Companies Ordinance, Chapter 32 of the Laws of the HKSAR, because, among other things, it has not filed its Annual Return at The Companies Registry since April 4, 2002.

Which is a criminal offence at law, actually.

As at the date of the last filing of its Annual Return, the Directors of Chinese United Press Ltd were:

Mr Saimond Ip of Taikoo Shing, the HKSAR; and,
Mr Albert Cheng Jing Han of Bowen Road, the HKSAR.
