## FOREFRONT INTERNATIONAL HOLDINGS LTD: WINDING-UP PETITIONS LAUNCHED AGAINST WHOLLY OWNED SUBSIDIARIES

A Substantial Shareholder of publicly listed <u>Forefront International Holdings Ltd</u> (Code: 885, Main Board, The Stock Exchange of Hongkong Ltd) has petitioned the winding up of 2 wholly owned subsidiaries of Forefront International Holdings Ltd.

Forefront International Ltd, which is, itself, in Liquidation in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), was known to be owned, beneficially, by the former Chairman of Forefront International Holdings Ltd, Dr Allen Yang Chien Chi.

Forefront International Ltd owns about 18.26 percent of the Issued and Fully Paid-Up Share Capital of Forefront International Holdings Ltd.

Solicitors, acting on instructions of the Court-appointed, Provisional Liquidators of Forefront International Ltd, Messrs Kelvin Edward Flynn and Desmond Chiong, have issued Winding-Up Petition Numbers 926 and 927, claiming that Forefront International Ltd is a creditor of Forefront Motors (Hongkong) Ltd and Ankor Service Ltd, both subsidiaries of Forefront International Holdings Ltd.

This is the latest episode in the saga of Forefront International Holdings Ltd, which was first uncovered by **TARGET** in 2001.
