

## My Dear Grandchild,

I note that China has become a little more harsh toward homosexuals, these days, and that male prostitution is being considered in a similar vein to female prostitution. I was surprised on both counts, to be honest with you, but things in this world never stand still, do they? What amazed me, however, was that there is a requirement in the Motherland for male prostitutes! I have seen movies about American male prostitutes, called gigolos in some quarters, but I had no idea that they had been exported to China. In these days of the Internet, I suppose, as the saying goes, the world has shrunk, considerably. In Hongkong, during the days when the British ran the place, there were quite a number of male judges, who were raving homosexuals, and did little to hide their innate propensity, you know. Even today, there are quite a number of barristers, practising at The Hongkong Bar, who are known to be buggerers of the best type (or should that read, of the 'worst' type?).
