

**DEBORAH ANNE SIMS:
THE HIGH COURT ORDERS WINDING-UP PROCEEDINGS TO COMMENCE**

The High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) has Ordered the winding up of Tiger Eye International Ltd.

Thus, it would appear, clearly, is the end of the business career of Ms Deborah Anne Sims, once the doyenne of the HKSAR, who was the Principal of [Tiger Eye International Ltd.](#)

According to the records of **TOLFIN** (The Computerised Online Financial Intelligence Service and Web-Based, Credit-Checking Provider), a representative of Tiger Eye International Ltd did not even front up at the Hearing of the Winding-Up Proceedings, held in the High Court of the HKSAR.

Master S. Kwang of the High Court has Ordered:

'UPON THE PETITION of Choi Yuk Chor of Flat 1, 25/F., Shui Pak House, Hong Pak Court, Lam Tin, Kowloon, a creditor of the abovenamed Company (Tiger Eye International Ltd), on the 2nd day of August, 2004, preferred unto the Court, AND UPON HEARING the Director of Legal Aid for the Petitioning Creditor and no one appearing for or on behalf of the Respondent Company AND UPON READING the said petition, an affirmation of Choi Yuk Chor filed herein on the 2nd day of August, 2004 verifying the said petition, an affirmation of Tse Kam Hung filed on the 17th day of August, 2004 and upon reading the Registrar's Certificate dated the 30th day of August, 2004. THIS COURT DOTH ORDER THAT the said Tiger Eye International Limited whose registered office is at 26/F., 88 Lockhart Road, Wanchai, Hong Kong, be wound up by this court under the provisions of the Companies Ordinance (Chapter 32) and that the Official Receiver be constituted provisional liquidator of the affairs of the company.

AND IT IS ORDERED THAT the Petitioner's costs of the said petition be taxed and paid out of the assets of the company.'

Ms [Deborah Anne Sims](#) was once hailed as the personification of the female physically fit, even after having given birth to 2 healthy children.

That was at the time that she was married to the flamboyant and very successful, Mr Eddie Phillips, who, at the time, was running the very remunerative, up-market fitness club chain in the HKSAR, Phillip Wain International.

Following the finalisation of the divorce proceedings, some years ago, Ms Deborah Anne Sims attempted to cash in on her once good name and lithe body by opening up a rival to Phillip Wain International, known modestly as: Body by Deborah International Health and Beauty Spa.

That entity received numerous complaints from customers and staff members over one thing or another and, eventually, in March 2002, it went belly up, leaving quite a number of people poorer by many millions of Hongkong dollars.

Even the rent on the former premises of Body by Deborah International Health and Beauty Spa was left unpaid, as Ms Deborah Anne Sims went 'underground', having lost all credibility.

After a sojourn of a year or so, Ms Deborah Anne Sims resurfaced and started, once again, to make the circuit of social events in an attempt to re-establish her once good name.
