KAMBOAT GROUP COMPANY LTD: IS THERE A LEAK IN THE HULL ?

<u>Kamboat Group Company Ltd</u> (Code: 318, Main Board, The Stock Exchange of Hongkong Ltd) appears to be facing a severe cash-flow problem.

How bad is the situation in this bakery/restaurant company, TARGET is not certain, but it is acute, to be sure.

The Chairman of Kamboat Group is being forced to sell off some of the company's family jewels to some of his friends and acquaintances, as well as topping up the coffers of the company in order to keep the creditor wolves away from his door.

Kamboat Group, earlier this year, was forced to sell 51 percent of its equity interest in its bakery subsidiary, Kamboat Bakery Ltd.

And, in September, Kamboat Group issued New Shares, representing about 9.09 percent of the Enlarged Share Capital, just to bring in what should have been a paltry sum of \$HK3.85 million, but, for the company, it was, clearly, needed as a matter of some urgency.

Restructuring of the company's finances is continuing to take place, today.

In the months of June and July, entities of Kamboat Group were on the receiving end of a number of claims, lodged in various Courts of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC).
