

**DEBORAH ANNE SIMS:
ANOTHER OF THE LADY'S ENTITIES, READY FOR THE RUBBISH DUMP !**

Ms [Deborah Anne Sims](#), whose flagship company is being wound up by Order of the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), is facing another major problem, one which could, just about, spell the end of her ill-fated attempts to be a businesswoman of any note – anywhere.

It would be fair to describe this ageing lady as being blessed with, what could aptly be termed as being the Reverse Midas Touch: Everything that she touches turns to shit instead of gold.

With [Tiger Eye International Ltd](#), being in the hands of the HKSAR Official Receiver, Ms Deborah Anne Sims is unable to operate in her normal fashion, out of the Wanchai offices of Tiger Eye International.

She has been Ordered to step down from any position in the company which she founded, with the High Court, having appointed the Official Receiver to oversee and to investigate the past business dealings of Tiger Eye International and, no doubt, make a determination as to the methods, employed by former Management in respect of the affairs of this private company.

But, today, another of Ms Deborah Anne Sims's companies is facing a very similar problem to that which Tiger Eye International Ltd was/is facing: It cannot pay its bills as they fall due.

According to Firm Wise Investment Ltd, New Team International Ltd has not paid rent on its offices in Central Hongkong for the past 2 months.

Firm Wise Investment has sued New Team International for \$HK41,106 in respect of the alleged non-payment of rent since August 2004 on:

Office Unit Number 2B on the 30th Floor,
The Centrium,
Number 60, Wyndham Street,
Western Hongkong.

This is the office of another of Ms Deborah Anne Sims's operations, known as The Face Magic Haven.

This is the 'shop', to which some vain, HKSAR ladies go in order to receive injections of Botox, a substance which, for a period of up to 6 months, may mask the telltale signs of facial wrinkles, which invade ageing ladies' faces – at about \$HK3,000 a pop!

The fact that New Team International cannot even pay, what should be a paltry sum of \$HK41,106, being 2 months' rent on this shop, is indicative of a financial cash crunch to be sure.
