

**DEBORAH ANNE SIMS:  
PRE-CHRISTMAS SPECIALS FOR BOTOX LOVERS !**

How The (Would-Be) Mighty Have Fallen !

If one is desirous to talk to the chief Botox lady of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), then, a telephone call to the shop of The Face Magic Haven, at Unit Number 2B on the 30<sup>th</sup> Floor, The Centrium, Number 60, Wyndham Street, Western Hongkong Island, is likely to result on one, striking pay-dirt.

Because the receptionist at this shop, who answers to the name of '*Carol*', sounds suspiciously like The Great Lady, herself: Ms [Deborah Anne Sims](#).

**TARGET**'s telephone call to The Face Magic Haven followed confirmation by this medium that at least one member of the former staff of this shop has called on the offices of the HKSAR Government's Labour Department – because of alleged non-payment of wages.

Miss Ada Yim, a Presiding Officer of The Labour Tribunal, adjudicated one such case, recently, when Ms Lo Ka Ying Fian sued New Team International Ltd, trading as The Face Magic Haven, in respect of allegations of non-payment of wages, etc.

This piece of intelligence was obtained from **TOLFIN** (The Computerised Online Financial Intelligence Service and Web-Based, Credit-Checking Provider).

The fact that Ms Lo Ka Ying Fian has had to sue New Team International was well expected by **TARGET** since the modus operandi of Ms Deborah Anne Sims is well established in the territory.

In last Wednesday's [TARGET Intelligence Report, Volume VI, Number 218](#), in an exclusive account about Ms Deborah Anne Sims, **TARGET** disclosed that New Team International has been accused of not paying rent on its offices since August 2004.

The corporate landlord has issued legal proceedings against New Team International, seeking \$HK41,106.

Ms Deborah Anne Sims, of course, is the Substantial Shareholder of New Team International and, today, it appears that she is sitting in as receptionist of her Botox shop.

In a conversation with a member of **TARGET**, '*Carol*' explained that there is a special on Botox injections for Christmas shoppers: \$HK2,800 per injection.

'*Carol*' explained that before a prospective Botox customer is given an injection, she is sent to a special Botox doctor, designated by The Face Magic Haven.

This Botox doctor, '*Carol*' said, has been trained in Australia in the intricacies of Botox and Botox injections – just in case things go terribly wrong, one must assume.
