ERVING BRETTELL v. DR SUSAN CAROLINE BERRY

The former wife of Barrister William Allen – Barrister William Allen is continuing to practise law in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), despite complaints as to his competency – has been sued by her solicitors' firm for about \$HK1.16 million, with the interest-rate clock, ticking over at the rate of \$HK567 per day.

She is Dr Susan Caroline Berry of Mount Davis Road, Pokfulam, the HKSAR.

Messrs Erving Brettell, the former solicitors' firm, which handled her divorce from Barrister William Allan, back in 1994, alleges in High Court Action Number 483 that it is entitled to:

- '1. money due for work done by the Plaintiff, as solicitors for the Defendant in the agreed sum of HK\$1,960,100.00;
- 2. costs.
- *3. interest at the agreed rate of 10% per annum from 1st April 2000 in the sum of HK\$1,162,947.00 and continuing at the daily rate of HK\$567.'*

Dr Susan Caroline Berry has been fighting the amount of the fees, charged by her (former?) solicitors' firm, for some years, according to the database of **TOLFIN** () (The Computerised Online Financial Intelligence Service and Web-Based, Credit-Checking Provider), ever since her divorce from her cavorting, ever-sexually hungry former husband, Barrister William Allen, who was accused of infidelity, during the time that he was married to Dr Susan Caroline Berry.
