

**JW MARRIOTT HONGKONG:  
WOULD YOU PAY \$HK1,000 FOR THIS ?**

The next time that **TARGET** () is asked about a major cock-up in a 5-star hotel, trying to function in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), this medium will, immediately, recall the name of JW Marriott, Hongkong.

This is because, just recently, this medium received an invitation to attend what was labelled as being '*an exclusive dinner hosted by Jerry Comfort, Director of Wine Education of Beringer.*'

The cost of the '*exclusive dinner*' was \$HK976.80 (\$HK888 plus 10 percent service charge).

The venue for the dinner, held last Tuesday (the invitation was sent out the previous Friday at 5:26 pm), was at the Chinese restaurant of JW Marriott, called Man Ho.

However, the text of the message to **TARGET** stated that the meal would be served, one day earlier, on Monday!
