

**HANG SENG BANK LTD SUES BARRISTER  
WILLIAM NIALL CARMICHAEL STIRLING FOR \$HK56,930.38**

Hang Seng Bank Ltd () (Code: 11, Main Board, The Stock Exchange of Hongkong Ltd) has just sued Mr William Niall Carmichael Stirling () for \$HK56,930.38.

Mr William Niall Carmichael Stirling is a barrister of record, practising in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC).

The last time that Mr William Niall Carmichael Stirling graced the pages of **TARGET** () was on Wednesday, September 27, 2006 (Please see [TARGET Intelligence Report, Volume VIII, Number 184](#)) when he was sued by The Commissioner of Inland Revenue of Hongkong for alleged non-payment of taxes, amounting to about \$HK205,756.92.

Mr William Niall Carmichael Stirling specialises in criminal cases.

He was called to the HKSAR Bar on February 23, 1983, according to the database of **TOLFIN** () (The Computerised, Online Financial Intelligence Service and Web-Based, Credit-Checking Provider).

In the latest claim against Mr William Niall Carmichael Stirling, Hang Seng Bank Ltd is alleging that the Defendant (Mr William Niall Carmichael Stirling) applied to the bank *'for the issuance of a Hong Kong Jockey Club MasterCard Card under the Hong Kong Jockey Club Membership Card Programme ....'*

The application was duly approved and the credit limit was set at \$HK50,000, it is alleged at Paragraph 2 of the Statement of Claim, attached to District Court Writ of Summons, Number 2333.

The current interest rate, charged by Hang Seng Bank Ltd, is 2 percent per month on all outstanding balances.

Paragraph 6 of the Statement of Claim alleges, inter alia, that *'in breach of the HKJC (Hongkong Jockey Club) Membership Card Agreement, the Defendant has failed and/or refused to make payment under the HKJC Gold MasterCard Card Account ... the Plaintiff (Hang Seng Bank Ltd) terminated the HKJC Gold MasterCard Card Account on 20th April 2007 ... despite repeated requests and demands made by the Plaintiff, the Defendant still fails and/or refuses to settle the outstanding balance ... as at 23rd May 2007, the Defendant was indebted to the Plaintiff in the sum of HK\$56,930.38 ...'*

Mr William Niall Carmichael Stirling is not the only barrister of record of the HKSAR, who has been found wanting by various parties of late.
