WHO WILL SLEEP IN THE WHITE HOUSE AFTER NOVEMBER ? WHAT WILL BE THE COLOUR OF COUNTRY'S POLITICS ?

It has been stated that Mr William Jefferson '*Bill*' Clinton was the first '*black*' American to become President of the United States of America.

President William Jefferson '*Bill*' Clinton was, of course, a whitey, but because he fought long and hard for the downtrodden black man of the US of his day, he was voted into office from 1993 to 2001 as the 42nd President of the most-powerful country of the world.

- 5. A higher minimum wage, linked to an inflation index.

One could say that this is a good and well, thought-out election platform for a candidate, hoping to attain the position of being the most-powerful man in the world.

Senator Barack Obama has, repeatedly, stated that he has never employed the so-called '*race card*' in his campaign to become the 44th President of the US.

In the soliloquy of Mark Antony in Shakespeare's play, Julius Caesar, it starts off:

'Friends, Romans, countrymen, lend me your ears I come to bury Caesar, not to praise him.'

Mark Antony, then, proceeds to praise his murdered friend by reading out the will of Julius Caesar to the assembled throng.

Is it any wonder that the US dollar's translation value vis-à-vis other *'hard'* currencies of the world is being eroded with every announcement about this US financial failure and that financial failure?

The Presidential Elections of November could well turn out to be the most-important political decision for the electorate of the United States in many a decade.

The colour of a man's skin is immaterial: It is the mettle from which a candidate is made that will win the day.

The United States still remains the best hope for the free world – because the alternative to freedom is unacceptable.
