

**SCUD GROUP LTD:
STOP INFRINGING ON MY MARKS !**

A fight has broken out between a man, who claims to own 3 patents – obviously in respect of batteries and/or battery packs – and publicly listed [SCUD Group Ltd \(\)](#) (Code: 1399, Main Board, The Stock Exchange of Hongkong Ltd).

This matter is partially explained in Action Number 1547, lodged in the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC).

The Plaintiff in this Writ of Summons is Mr Tai Chi Chung, who is suing SCUD (Fujian) Electronics Company Ltd ([]), a wholly owned subsidiary of SCUD Group Ltd, for, inter alia, Injunctive Relief.

The Endorsement of Claim, attached to the Writ of Summons, is claiming, among other things:

1. An Injunction to restrain SCUD (Fujian) Electronics Company Ltd from infringing on Registered Trade Marks, Numbers 199806570, 199806571 and 199806572;
2. An Injunction to restrain the Defendant from manufacturing, selling, advertising, publishing, offering for sale or exposing for sale, or possession in the course of trade and/or exhibiting in public or making invitation to treat or distributing in the course of trade the Defendant's product(s) *'under and by reference to trade mark(s) identical to or substantially similar to the Plaintiff's Marks and/or causing, enabling or assisting others to do any of the aforesaid acts'*;
3. An Order for delivery up of all goods ... *'which by the Defendant would offend against any of the foregoing injunctions'*;
4. Damages;
5. An Order for Discovery;
6. An Order for payment by the Defendant *'of all sums found due to the Plaintiff ...'*; and,
7. Costs.

This is the second time that Mr Tai Chi Chung has figured in any Legal Action in the High Court of the HKSAR, according to the database of **TOLFIN** () (The Computerised, Online Financial Intelligence Service and Web-Based, Credit-Checking Provider)

TOLFIN's records show that, on August 12, 2006, Miscellaneous Proceedings Action, Number 2580, was filed in the matter between SCUD (Fujian) Electronics Company Ltd, SCUD (Fujian) Battery Company Ltd ([]) and Mr Tai Chi Chung.

SCUD (Fujian) Battery Company Ltd is another wholly owned subsidiary of SCUD Group Ltd.

The business of SCUD (Fujian) Electronics Company Ltd is the manufacture and sale of batteries, battery chargers and related accessories for mobile telephones, digital cameras, accessories for notebook computers

and other electrical appliances.

SCUD Group Ltd went public in the HKSAR on December 11, 2006, when it launched an Initial Public Offering in order to collect about \$HK580 million from the HKSAR investing public.
