

**BENFUN INTERNATIONAL HOLDINGS LTD:
BRITISH VIRGIN ISLANDS SHAREHOLDER SUES FOR \$HK31.23 MILLION**

A fight has broken out between a company, domiciled in the British Virgin Islands, and publicly listed Benefun International Holdings Ltd () (Code: 1130, Main Board, The Stock Exchange of Hongkong Ltd).

The British Virgin Islands company is Hero Rich International Ltd which claims to be the legal and beneficial owner of 234,375,000 shares in the Issued and Fully Paid-Up Share Capital of Benefun International Holdings Ltd.

There is no mention in the 2008 Annual Report of Benefun International Holdings Ltd of Hero Rich International Ltd, which is the Plaintiff in Action Number 1433, lodged in the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC).

However, Hero Rich International Ltd is claiming \$HK31,227,896.94 from Benefun International Holdings Ltd.
