

**CHINA MEDICAL AND BIO SCIENCE LTD:
THIS IS A TORT OF DECEIT,
CRIES ALLEGED DIDDLED BUSINESSMAN**

Mr Ang Tai Hoi (), a businessman, engaged in the import and export industry of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), has, acting in person, issued Legal Proceedings in the High Court of the HKSAR, alleging, inter alia, Damages for Tort of Deceit and Misrepresentation, naming the following Defendants:

China Medical and Bio Science Ltd ()	1 ST Defendant
Mr Wong Sai Wa ()	2 ND Defendant

(Tort is defined as being a private or civil wrong or injury, other than breach of contract, for which the Court will provide a remedy in the form of an action for damages. It is a violation of duty, imposed by general law or otherwise upon all persons, occupying the relationship to each other which is involved in a given transaction.)

China Medical and Bio Science Ltd is a publicly listed company, being Stock Code Number 8120, The Growth Enterprise Market of The Stock Exchange of Hongkong Ltd.

Mr Wong Sai Wa was one of the Founders of China Medical and Bio Science Ltd and was appointed as Joint Managing Director of the company in 1999. He remains an Executive Director of the company to this day.

The Plaintiff in HKSAR, High Court Action, Number 2031, alleges that he is illiterate in the English language, but had had a secondary school education although he had never studied English.

The Statement of Claim, attached to Writ of Summons, Number 2031, attests that the Plaintiff had never strayed from his core business of import and export, other than some investments in properties and '*some reliable blue-chips shares*', according to Paragraph 8.

However, this Paragraph goes on to allege:

'... Due to dealings with the 1st Defendant through Dr. Liu (Dr Francis Liu []), Dr. Yu (Dr Jimmy Yu []), Mr Lo (Mr Lo Ka Ying []) and the 2nd Defendant, as pleaded hereinbelow, the Plaintiff started to invest in the shares of the 1st Defendant for the first time in his life, during 5th October, 2007 and 29th November 2007.'

(Dr Francis Liu and Dr Jimmy Yu are described in the Statement of Claim as being in the employ of the China Medical and Bio Science Ltd while Mr Lo Ka Ying is said to be a solicitor in the HKSAR law firm of Lawrence K.Y. Lo and Company () and, allegedly, '*held himself out to be acting for and on behalf of the 1st Defendant in conclusion of certain commercial transactions and execution of legal documents between the 1st Defendant and the Plaintiff or his private company.*')
