

**SHOULD MR K. SITAL BE ENTITLED TO REMAIN
A JUSTICE OF THE PEACE AND_
BE HONOURED WITH A B.B.S. ?**

And What About His Son ?

One of the 2, most-influential, resident ethnic Indians of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) has been caught with his trousers down – right around his ankles.

He is Mr Sitaldas Kewalram Motwani, also known, popularly, as Mr K. Sital.

Mr Sitaldas Kewalram Motwani has had to pay close to \$HK500,000 for his fraudulent acts as well as passing himself off as an employee of G.C. Nanda and Sons Ltd.

In addition, he has been required, as part of the settlement with G.C. Nanda and Sons Ltd, to post an advertisement in an English daily newspaper in the HKSAR, which reads as follows:

'APOLOGY

'K. Sital Motwani, J.P. and the directors of Style Asia Ltd. express their sincere regret for any inappropriate conduct in relation to G. C. Nanda & Sons Ltd. ("G.C. Nanda"). In particular, any unauthorised use of their trademarks, letterheads, logos, etc. is deeply and wholeheartedly regretted.

'As agreed with G.C. Nanda, a suitable sum will be paid in restitution and will be further donated to a charity nominated by Mr. Sunil Nanda.

'The directors of Style Asia Ltd. always hold G.C. Nanda in high regard and profoundly regret any misunderstanding that may have arisen. It is hoped that the once cordial relationship between the parties will be restored.'

According to very reliable sources, Mr Sitaldas Kewalram Motwani has been counterfeiting the letterheads of G.C. Nanda and Sons Ltd as well as passing himself off as Marketing Director of this HKSAR, travel agency, whose history goes back to 1951.

He, also, created and had printed his own name card, purported to have been authorised by G.C. Nanda and Sons Ltd – without obtaining the permission of the beneficial owners of this 58 year-old, HKSAR travel agency.

According to the management of a 5-star hotel in Johannesburg, South Africa, Mr Sitaldas Kewalram Motwani booked a room for one night in February 2008, the booking, having been made by facsimile correspondence, using the purported letterhead of G.C. Nanda and Sons Ltd.

The raison d'être for the skulduggery of Mr Sitaldas Kewalram Motwani was in order to obtain a discount on the cost of the room.

Mr Sitaldas Kewalram Motwani sent his fraudulent facsimile correspondence, bearing a likeness of the letterhead of G.C. Nanda and Sons Ltd, to the Johannesburg hotel – but the facsimile communication was sent from the offices of Style Asia Ltd, the company, beneficially owned by Mr Sitaldas Kewalram Motwani in the HKSAR.
