## BELGIAN BANK FIRES OFF CLAIMS AGAINST HONGKONG INDIANS: <u>\$HK55 MILLION IS BEING CLAIMED ?</u>

Antwerp Diamond Bank NV, which is domiciled in Belgium, has filed Writs of Summons in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), claiming more than \$HK55 million from 5 residents/entities and one company, all of which appear to have domiciles in the territory and all of which appear to be the property of ethnic Indian nationals.
