

**THE KOWLOON CLUB:
ANOTHER DAY; AND, ANOTHER CLAIM FOR MORE MONEY**

Another lawsuit has been filed in the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), naming KLUB Management Services Ltd () as the lone Defendant.

KLUB Management Services Ltd is wholly owned by September Phoenix Ltd which, in turn, is the operator of '*Bistro on the Bund* ()' and '*Shanghai Dream* ()',

both being food outlets of The Kowloon Club ().

The Plaintiff in District Court Action, Number 1326, is Hui Kam Cheung (), trading as Siu Man Yau Store ().

The Statement of Claim, attached to Writ of Summons, Number 1326, alleges that the Plaintiff sold and delivered goods to the Defendant between June 30, 2009, and April 17, 2010.

The total market value of the goods, sold and delivered, is said to have been \$HK219,947.35.

Only \$HK45,000, being a partial payment, has ever been received by the Plaintiff, it is alleged, and, today, the Plaintiff is seeking \$HK171,970.45 from the Defendant.

The filing of HKSAR, District Court Writ of Summons, Number 1326, is the eighth such legal claim, made against KLUB Management Services Ltd since the beginning of this year and the twenty-fifth legal claim, lodged in the past 14 months.

On Friday, March 25, 2011, **TARGET** () penned a report about The Kowloon Club, headlined: '[**THE KOWLOON CLUB: A WEED BY ANY OTHER NAME WOULD SMELL THE SAME**](#)'.

In that **TARGET**, this medium reported that Hing Lung Food Place Ltd was the Plaintiff in respect of High Court Action, Number 461, and it was/is seeking about \$HK1,142,104.40 from KLUB Management Services Ltd.

Hing Lung Food Place Ltd is a purveyor of frozen meat as a wholesaler and a usually reliable source, close to this company, told **TARGET** that its Management was negotiating, directly, with Mr Nari (also known as Larry) Parmanand, a Director of KLUB Management Services Ltd, with a view to finding a solution to the problem of this not insignificant amount of money, owed to the supplier – since September of 2009.

Hing Lung Food Place Ltd continues to engage in supplying The Kowloon Club with frozen meat, but on a **Cash On Delivery (COD)** basis, only, **TARGET** is led to believe.

As this medium pointed out on Page 11 of **TARGET** Intelligence Report, Volume XIII, Number 58, Associated Meat Distributors Ltd, owned legally by the paterfamilias of the family that owns Hing Lung Food Place Ltd, is the beneficial owner of 25,000 shares in the Issued and Fully Paid-Up Share Capital of September Phoenix Ltd, representing, at the time of the purchase, about 3.28 percent.

The (present) Kowloon Club, which operates from Harbourfront Horizon All Suite Hotel in Hunghom Bay,

Kowloon, could be likened to the rebirth of this ill-fated social club, the phoenix, so to speak, rising from smoldering ashes of the former insolvent club which had rented premises in Tsimshatsui, Kowloon ... [CLICK TO ORDER FULL ARTICLE](#)
