

My Dear Grandchild,

My dear husband, Bo-Bo, is in complete agreement with Chief Executive Donald Tsang Yam Kuen (). When the Chief Executive, in the Legislative Council Chamber, stated, on Thursday, May 19, that forces of evil were working hard to thwart the constructive suggestions of the Government of Hongkong, Bo-Bo nearly jumped out of his chair in utter amazement.
