## THE ESTATE OF THE LATE NINA WANG IS ON THE WARPATH

The Estate of the late Ms Nina Wang () has issued legal proceedings in the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), naming all of the past Directors of RCG Holdings Ltd ([]) (Code: 802, Main Board, The Stock Exchange of Hongkong Ltd) in respect of the 2007 Financial Year, as Defendants to the Action.

According the database of **TOLFIN** (), the Computerised, Online Financial Intelligence Service and Web-Based, Credit-Checking Provider, Ms Nina Wang, via Veron International Ltd, was, at one time, the beneficial owner of 25.90 percent of the Issued and Fully Paid-Up Share Capital of RCG Holdings Ltd.

However, as at December 4, 2013, the equity interest of Veron International Ltd in RCG Holdings Ltd had fallen to 7.86 percent. Veron International Ltd is a company, domiciled in the British Virgin Islands.

As for the Sixth Defendant, named in the Writ as Mohd Azumi bin Mohamed, TOLFIN's information is that his full name is General Dato' Seri Mohd Azumi bin Mohamed.

He was, for just one year – from February 2009 to February 2010 – an Independent Non-Executive Director of RCG Holdings Ltd.
