

**SEAMLESS GREEN CHINA (HOLDINGS) LTD:
THE COMPANY GOES ON THE OFFENSIVE**

Publicly listed [Seamless Green China \(Holdings\) Ltd \(\[1\]\)](#) (Code: 8150, The Growth Enterprise Market [The GEM] of The Stock Exchange of Hongkong Ltd), along with one of its wholly owned subsidiaries, have filed a Writ of Summons in the High Court of The Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), claiming Damages from seven-named Defendants in respect of a purported agreement for the purchase of a company in the amount of \$HK23.80 million.

The Second Plaintiff is a wholly owned subsidiary of the First Plaintiff.

The Defendants are described as being:

- The First Defendant is a company, incorporated in The Republic of Vanuatu;
- The Second Defendant is a merchant who is said to live on the Eighth Floor of Number 67, Tung Choi Street, Mongkok, Kowloon, the HKSAR. He is said to have had (and may still have) a 27-percent, equity interest in the Third Defendant;
- The Third Defendant is a company, domiciled in the British Virgin Islands (BVI);
- The Fourth Defendant is a company, incorporated in the HKSAR and is a wholly owned subsidiary of the Third Defendant;
- The Fifth Defendant is an individual, said to reside on the Third Floor, East, Block 705, Pengji Industrial Park, Number Two, Peng Xing Road, Luohu District, Shenzhen, the PRC, and is/was the beneficial owner of 55 percent of the Issued and Fully Paid-Up Share Capital of the Third Defendant;
- The Sixth Defendant is said to have an office at Room One, 26th Floor, Tower Two, Lippo Centre, Number 87, Queensway, Admiralty, the HKSAR. He was, in December of 2012, an Executive Director of the First Plaintiff; and,

- The Seventh Defendant is said to have a residence at Flat 9D, Block One, Golden Dragon Building, Numbers 152-163, Tai Lin Road, Kwai Chung, New Territories, the HKSAR. He, was, in December of 2012, an Executive Director of the First Plaintiff.
