

### HONGKONG SOLICITOR SUES FORMER CLIENT FOR \$HK2 MILLION

Mr Anthony Leung Tat Kin (), the Sole Proprietor of the solicitors' firm of Leung and Associates (), has issued legal proceedings in the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), naming publicly listed [China National Culture Group Ltd \(\)](#) (Code: 745, Main Board, The Stock Exchange of Hongkong Ltd) as the lone Defendant.

Mr Anthony Leung Tat Kin is claiming \$HK1,944,909.50, plus Interest, Costs and Damages for Breach of Contract from the Defendant with regard to '*the substantial legal advice and services rendered by the Plaintiff*'.

According to the General Endorsement of Claim, attached to Writ of Summons, Number 1874 of 2015, Mr Anthony Leung Tat Kin has been owed money from the Defendant in respect of the '***Outstanding Invoices***', dating back to December 20, 2010.

his is not the first time that Mr Anthony Leung Tat Kin has sued China National Culture because, according to the database of **TOLFIN** (), the Computerised, Online Financial Intelligence Service and Web-Based, Credit-Checking Provider.

In fact, he has sued this publicly listed company three times in the HKSAR District Court.
