MR NELSON TANG YU MING: IS THIS THE END OF THE LINE FOR THIS FORMER HIGH-FLYER?

It appears that the curtain has come down on one of the final scenes in the life and times of a former high-flyer of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC).

Mr Nelson Tang Yu Ming () is the First Defendant in Miscellaneous Proceedings, Number 278 of 2016, the Plaintiff, being Lei Shing Hong Credit Ltd ().

The other two Defendants are:

Ocean Bridge Investments Ltd () Hyde Park Group Ltd Second Defendant Third Defendant

According to the database of **TOLFIN** (), the Computerised, Online Financial Intelligence Service and Web-Based, Credit-Checking Provider, the Third Defendant, as at February 2010, was wholly owned by the First Defendant.

Hyde Park Group Ltd, in turn, owns all of the shares of the Second Defendant – Ocean Bridge Investments Ltd.

TOLFIN's Property Transaction Database indicates that, as at May 28, 2001, Ocean Bridge Investments Ltd was the purchaser of House Number Six, Black's Link, Hongkong Island.

The consideration paid for this house was \$HK31 million, exactly, **TOLFIN**'s records indicate.

Hyde Park Group Ltd, according to **TOLFIN** (), was the purchaser of Hatton House, Number 15, Kotewall Road, Hongkong. It purchased this property on April 24, 2006, the consideration, being \$HK20.50 million.

Then, on March 28, 2008, Hyde Park Group Ltd and Ocean Bridge Investments Ltd borrowed \$HK130 million from Chow Tai Fook Jewellery Company Ltd (), using the Black's Link house and the Hatton House as security for the loan.

On September 17, 2013, Hyde Park Group Ltd and Ocean Bridge Investments Ltd again tapped the coffers of Chow Tai Fook Jewellery Company Ltd for a further loan of \$HK10 million, using the same security for that loan.
