

**CHINA KINGSTONE MINING HOLDINGS LTD:**  
**THE SAGA CONTINUES:**  
**BUSINESSMAN CLAIMS HE IS OWED \$HK24 MILLION**

A new twist appears to have come to light in the matter of the continuing litigation between various parties and publicly listed China Kingstone Mining Holdings Ltd () (Code: 1380, Main Board, The Stock Exchange of Hongkong Ltd).

In the latest episode of this continuing saga, relating directly or indirectly to China Kingstone Mining Holdings Ltd, Mr Li Jia Ju (), the Plaintiff in Action Number Five of 2018, lodged in the Commercial List of the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC), has made claims against three Defendants, alleging that he is owed \$HK23,691,617.00, plus Interest, Costs and Further and/or Other Relief.
