

**CHINA QINFA GROUP LTD:**  
**THIS COAL-MINING COMPANY IS THE SUBJECT OF JUDICIAL**  
**PROCEEDINGS, CLAIMING PAYMENT OF 150 MILLION RENMINBI**

Action has been taken in the High Court of the Hongkong Special Administrative Region (HKSAR) of the People's Republic of China (PRC) to enforce a 28-month-old Judgement, obtained in the Zhuhai Municipal Intermediate People's Court of the PRC against, inter alia, publicly listed China Qinfa Group Ltd () (Code: 866, Main Board, The Stock Exchange of Hongkong Ltd), its Chairman and its Controlling Shareholder.

In HKSAR High Court, Miscellaneous Proceedings, Number 542 of 2019, in the matter of Mainland Judgement (Reciprocal Enforcement) Ordinance, Chapter 597 of the Laws of the HKSAR, and in the matter of '*a judgement given by the Zhuhai Municipal Intermediate People's Court of China on 30 December 2016*', an HKSAR solicitors firm, acting on behalf of the Plaintiff, is seeking 150,002,862.23 renminbi (RMB) (about \$HK174,088,821.82, as at today's translation rate of \$HK1.16 = RMB1.00).
